

India–Canada Relations in the Shadow of Khalistani Movement

***Abstract*—India and Canada boast a long-standing relationship built on common ground – democracy, human rights, and multiculturalism, common wealth membership and strong people to people connections. Despite these commonalities the relationship has gone through several fluctuations because of disagreements involving nuclear policy, diaspora disruptions and security concerns which has ruptured healthy economic cooperation, through bilateral trade and investments. The diplomatic connections have gone through severe fluctuations specifically because of 2023 allegation headed by Canadian government towards India in killing Hardeep Singh Gujjar creating challenges for Indian students obtaining Canadian visas. To navigate these complexities and strengthen ties, both nations must find common ground while acknowledging areas needing diplomatic efforts. This study thus examines through an extensive qualitative research method, the importance of recent diplomatic crisis, the impact of indo-pacific in shaping the relation and the consistent effect of Indian diaspora entwined with Khalistani movement in this complex international environment.**

visit to Canada in 2015, the first bilateral visit by an Indian Prime Minister in over four decades. Modi's emphasis on economic diplomacy has led to the expansion of trade and investment between the two nations, with efforts to tap into Canada's expertise in areas such as clean energy, technology, and innovation. Additionally, Modi's proactive engagement with the Indian diaspora in Canada has contributed to strengthening people-to-people ties and fostering cultural exchange. His tenure has also seen a deepening of cooperation in areas such as defense, security, and counter-terrorism. Overall, Prime Minister Modi's tenure has played a pivotal role in elevating the India-Canada relationship to new heights, laying the foundation for enhanced cooperation and collaboration in the years to come.

Both the nations have collaborated within specific international organizations like that of United Nations, G20, Commonwealth and World Trade Organization respectively. The rise of India as a major economic state in South East Asia and Canada's specific strategies towards Indo-Pacific has inevitably made the nations inculcate a pragmatic relation. Parallel to this, the recent tensions based on diaspora activism have made the relation palpable. The paper emphasizes in analyzing the contemporary trajectory by evaluating historical bonding, economic cooperation, and emerging challenges based on the Khalistani movement which has been a long drawn obstacle in India-Canada cooperative ties.

II. METHODOLOGY

The study has adopted a qualitative research methodology giving emphasis on academic journals, government reports, policy documents, books, newspaper articles and official statements available in public domain. The study deploys historical and analytical approaches for the understanding of the evolution and continuity of the diplomatic ties between the two nations. Specific comparative analysis has been taken into account from 2014 after Prime Minister Modi's advent and triggering diplomatic tension based on the Khalistani movement and diaspora politics both in India and Canada.

This push away relation went on for several decades. With the advent of Globalization in 1990s and international economic shift made the situation different as trade became inevitable for economic prosperity. In early twenty first century the relation upgraded with strengthening of India-Canada nuclear ties in

2010. With Modi Governments coming into to power and his visit to Canada in 2015 relaxed the relation symbolizing renewed political commitment and expansion of economic engagements. Bilateral ties flourished further with the influx of Indian immigrants to Canada in the late 20th century, contributing to cultural exchange and economic cooperation. Since then, both countries have worked to deepen cooperation in multiple areas, including trade, defense, education, and technology. High-level visits and exchanges have become more frequent, underscoring the growing importance of the relationship on the global stage. Today, India and Canada continue to strengthen their ties through dialogue, collaboration, and mutual respect, with a shared vision for a more prosperous and secure world.

IV. STRATEGIC PARTNERSHIP

The Khalistan movement, seeking an independent Sikh state in the Punjab region of India, has been a source of friction between the two countries, particularly due to the presence of the Sikh diaspora in Canada who are sympathetic to the cause. Canada's

historical support for Sikh separatist movements, coupled with the presence of Khalistani elements within its Sikh community, has led to diplomatic challenges and occasional friction with India. One of the key controversies emerged during Prime Minister Justin Trudeau's visit to India in 2018 when some members of his delegation were found to have links with Sikh separatist groups. This led to strained relations between the two nations, with India expressing concerns over Canada's perceived tolerance of separatist activities on its soil. Adding fuel to fire, the allegation of killing Hardeep Singh Gujjar (leader of Khalistani movement in Canada) , by Indian diplomats have significantly ruptured the long standing cooperative links. The incident highlighted the complexities of managing relations between diaspora communities and their countries of origin, particularly when the diaspora's activities intersect with sensitive political issues. Furthermore, the issue of alleged funding and support for Khalistani groups by elements within the Canadian Sikh community has been a point of contention. India has accused certain individuals and organizations in Canada of financing and promoting separatist activities, leading to diplomatic confrontations and calls for Canada to take action against such groups. However, Canada has emphasized the importance of upholding freedom of speech and expression while condemning violence or terrorism in any form. These challenges have contributed to occasional diplomatic tensions and strained relations between India and Canada, affecting bilateral cooperation in various areas. The perception of Canada as a haven for Khalistani activists and sympathizers has led to mistrust and suspicion on the part of the Indian government, hampering efforts to deepen engagement and collaboration between the two countries.

Despite these challenges, both India and Canada have reiterated their commitment to maintaining constructive dialogue and finding mutually acceptable solutions to contentious issues. Efforts to

address concerns related to separatist activities and terrorism have been made through diplomatic channels and cooperation in counter-terrorism initiatives. However, achieving a lasting resolution to the Khalistan issue and restoring trust between the two nations will require continued engagement, dialogue, and a shared commitment to upholding the principles of sovereignty, territorial integrity, and respect for international law. Balancing the interests of diaspora communities with the imperatives of bilateral relations remains a complex and ongoing challenge for both India and Canada
